## VE Exams – February 3

Volunteer Exams will be held on Saturday, February 3, 2001, at the Woodmen of the World building on Highway 42, just north of Dayton, Virginia.

Advance reservations are not required. Walk-ins are welcome and invited.

Cost of this session is \$10.00. The cost covers the entire testing session, regardless of how many test elements a candidate takes.

Coordinator of this session is Gayle Shull, KU4XN.

The registration starts at 9:00 am. Testing will begin as soon as all participants are registered.

If you hold a General class or higher ham license, you are qualified to serve as a Volunteer Examiner. Give Gayle a call at 540-828-2132 for more information.

Directions to the session:

From Harrisonburg, take Hwy 42 (South High Street becomes John Wayland Highway) south one mile past the WalMart supercenter. The Woodmen of the World building is on your right.

From Interstate 81, take Exit 240 (Bridgewater, Mount Crawford). Go west on Highway 257 (towards Bridgewater). Go 3 miles, into Bridgewater. Turn right at the traffic light, onto Highway 42. Follow 42 north just over 3-1/2 miles, and the Woodmen of the World building will be on your left.

Future VE testing sessions are now scheduled for **April 14, June 2, August 4, October 6, & Dec. 1.**

## SkyWarn Training Classes

The National Weather Service (NWS) has announced the following courses to be offered in February. All courses below will be held at the Sterling (Dulles) Weather Forecast Office.

**BASIC I** — This is the fundamental SkyWarn course. You must take Basic I before you can take any other SkyWarn courses. Completing this 3-hour course qualifies you as a full SkyWarn weather observer, and you will

receive your SkyWarn locator ID. This course will be held on February 28th, from 7 pm to 10 pm.

**BASIC II** — This is a followup course for those who have completed Basic I training several months ago. This course is optional, and provides additional weather training and reporting briefing. The Basics II class will be held February 15th, from 7 pm to 9 pm.

Both courses are free of charge. Hams are welcome and invited to attend. Advance Registration is required.

The training will be held Saturday, February 10th, at the State Police building in the Fontaine Research park, on the west end of Charlottesville.

This location is right off the 29 By-Pass, just north of Interstate 64, and is easily accessible from the Interstate.

## Amateur Radio Scholarships

Are you a licensed amateur planning on going to college or university,?

You are qualified to apply for over a hundred different scholarships to help you pay for your tuition, books, and expenses.

The ARRL Foundation itself sponsors over a dozen scholarships, ranging from \$250 to \$2000 each. Information can be found at: [www.arrl.org/arrlf/](http://www.arrl.org/arrlf/) The application deadline for ARRL Foundation scholarships is generally February 1, so hurry.

Also, the Foundation for Amateur Radio (FAR) sponsors a large number of scholarships (almost 75!) ranging up to \$3000. Some of these scholarships are specifically reserved for applications from Virginia. In many cases, the applicant does not need to pursue a radio-related course of study. Application forms and additional information are available by letter or QSL postmarked prior to April 30, 2000, from FAR Scholarships, PO Box 831, Riverdale, MD 20738.

Also, the Dayton Amateur Radio Association accepts applications from amateurs all over the country for their annual scholarships. For information, send a SASE to Dara Scholrshhips, 45 Cinnamon Ct., Springboro, OH 45066-1000. DARA's deadline is usually around May for the following year's awards.

## WA4EEN Needs Net Control Stations...

Imagine the D.C. beltway with no signs, no pavement or lane markings, no exit or entrance signs, and no speed limit! Chaos!

Getting a bunch of hams together on one frequency can be every bit as chaotic.

In an emergency, however, it is critical to have a large number of hams on the same frequency. Thus, one ham is designated Net Control to organize the group. All other stations agree to follow the directions of Net Control, and things go smoothly.

But being Net Control in an emergency is a very difficult job. For this reason, we have on-the-job training, but without the stress of a real emergency: ARES Nets

The Shenandoah Valley has three ARES Nets which meet every Sunday night, every Monday night, and the 2nd and 3rd Thursday nights of each month (see the schedule on page 7). The Rockingham County net is a net that rotates the position of Net Control among local hams, in an effort to increase the pool of experienced Net Control operators.

Norman, Benner, KA3EEN, is the highly esteemed Net Control Coordinator for the Rockingham County ARES Nets.

If you would like to try your hand at serving as Net Control, give Norman a call at 540-289-5801, or check into one of the ARES nets and ask for KA4EEN. He has prepared a script to make the job easier.

Participants of the nets are great fellows (and gals), and they understand a new control station's apprehension. The group is always happy to welcome a new Net Control station.

## King David's Nine Little Alligators... Where's your Inventory?

In past issues of the Monitor, KD9LA has written about the "gotcha's" that spring up on you when you are serving an emergency assignment.

A good emergency communicator must be prepared for all the alligators that pop up and interfere with your assignment to drain the swamp.

One step in being prepared is to know in advance exactly what frequencies you can operate on.

No, I'm not talking about what frequencies your radio will transmit and receive

on. I'm talking about which frequencies you can communicate on!

In an emergency, you can't afford to waste time "trying out" different repeaters in order to find one that you can work from your location. It wastes time if you have to test a simplex frequency to see if it will work between your station and a Net Control, EOC, fire station, or other post.

Don't wait until an emergency. Create an inventory of workable frequencies. On the following page is a list of 2m repeaters that can be worked from various

areas of the valley. Which ones can you work from your QTH? From your closest fire station with an HT? From your car in various areas of the county?

On the next ARES net, listen on the input as the stations check in. Which stations can you copy direct from your QTH?

Knowing your capabilities can be critical in an emergency. Start listing your inventory today. And if you know of repeaters not listed on the next page, let KD9LA know so they can be added.
