As I write this, the Christmas Season is upon us and the snow is falling and it looks like we will have a white Christmas.

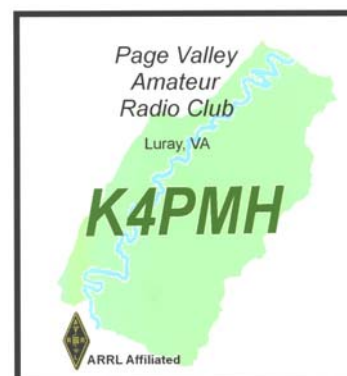

Hams of the Month

Richard Haxton KC4AN and Phyllis Haxton N4VZC

The year was 1962. John Kennedy was still alive. John Glenn was getting ready to be the first American to reach orbit. Computer chips hadn't yet been invented. Touch-tone telephone dialing was still in the laboratory. Commercial microwave ovens were still three years in the future. There were no cell phones, personal computers, or airport x-ray machines. But Russia was a formidable threat to the U.S., especially with missiles being shipped to Cuba.

In 1962, a young telephone company employee by the name of Richard Haxton went to the FCC office in Washington D.C. and took the test for his first ham radio license.

Richard, today KC3AN, doesn't even remember his first callsign, but it was a WN3-something, he reports. When he took the test to upgrade to General, he initially flunked the code test, but the FCC employee suggested he take the written portion, which he passed, and earned his technician's license WA3IVB.

Richard worked at the phone company AT&T, and held the title of "customer engineer", even though he admits he never went to engineering school. "They just give you the title instead of increasing your pay," he jokes.

Richard's largest customer was the Federal Government. He says, "I did an awful lot with the 'Cold-War Stuff'. You can say that I had a lot to do with those 'holes-in-the-ground'."

Apparently a lot of what went on during those days is classified, and he can't talk a lot about it. "But the guys who worked with the holes in the ground in those days will know exactly what I'm talking about," he says.

Richard met Phyllis while she was working at the Army's Quartermaster Corps. Phyllis too quickly became bitten with the ham radio bug, and was first licensed in the 1960's. She took her tests at the FCC's Richmond office. Together they began getting deeper and deeper into the hobby that still keeps them together.

Phyllis later held positions with the Montgomery County Tax Department, the Department of Interior, and the school system, while raising the kids who are now grown and gone.

Together they raised four children — two boys and two girls, and they presently have 2 grand-daughters and a grandson.

Their ham radio operations go way back. They ran phone patches back in the 1960's and 1970's, using a \$5 beam on a surplus pole at their home QTH in Montgomery County Maryland.

Upon retirement, they moved to Northumberland County -- the very area now inhabited by Sandy Mullins, W4PZC, long-time treasurer of MARA. Phyllis relates: "While we were there, we were both ac-

tive in the RARA, the rah-rah we call it, the Rappahannock Amateur Radio Association. We got to know a lot of the Shenandoah valley hams from our contacts we made with them on the air — Dick W3HXH, Gerry K4RBZ, and of course we knew Hugh K3EC.

"We came to Harrisonburg to see our friends, and fell in love with the place. Since Northumberland County is so far away from ... well, literally everything, we decided to move here."

Richard and Phyllis are both members of the Quarter Century Wireless Association ("and have been for many, many years," points out

Phyllis). They have taken several cruises with the QCWA.

They purchased a house in Harrisonburg and set up a nice station, becoming active in the Massanutten Amateur Radio Association from its inception.

But a couple of years ago, Phyllis took a nasty fall down the staircase. With a split head, broken bones, and a concussion, she lost



at least 10 years' worth of memory. "There is so much of my life that's simply gone," she says. "I spent months in Harrisonburg Rehab Center — those people there are miracle workers. My doctor didn't think I was going to make it."

But she did, and with the exception of about 10 years worth of memories, she's back in the swing of things.

"We sold our house since the doctor didn't think much of her going up and down the stairs anymore," says Richard. "We love it here in the Birch community."

Richard and Phyllis share a nicely stocked station, working HF and the VHF/UHF bands. The retirement villas don't allow huge towers and antennas, but in a show of ingenuity, Richard has run his coax out to his vehicle, which sports a nice set of mobile antennas. He can work the world from the comfort of his station, cozy inside the second bedroom of the villa, by using the mobile antennas on the truck. He uses a through-the-window insert panel from MFJ to get the signal out of the house.

Another demonstration of ingenuity is his 75-meter antenna: his rain gutter and downspout! As shown in the accompanying photographs, an alligator clip connects the whip end of the antenna to the aluminum downspout, adding in the metal from the gutter running the entire length of the villa.

"It really works, too," Richard reports.

Richard and Phyllis continue to be active on the bands, and often participate in public service events. They are regulars on the Monday night ARES net and many of the HF nets, too.

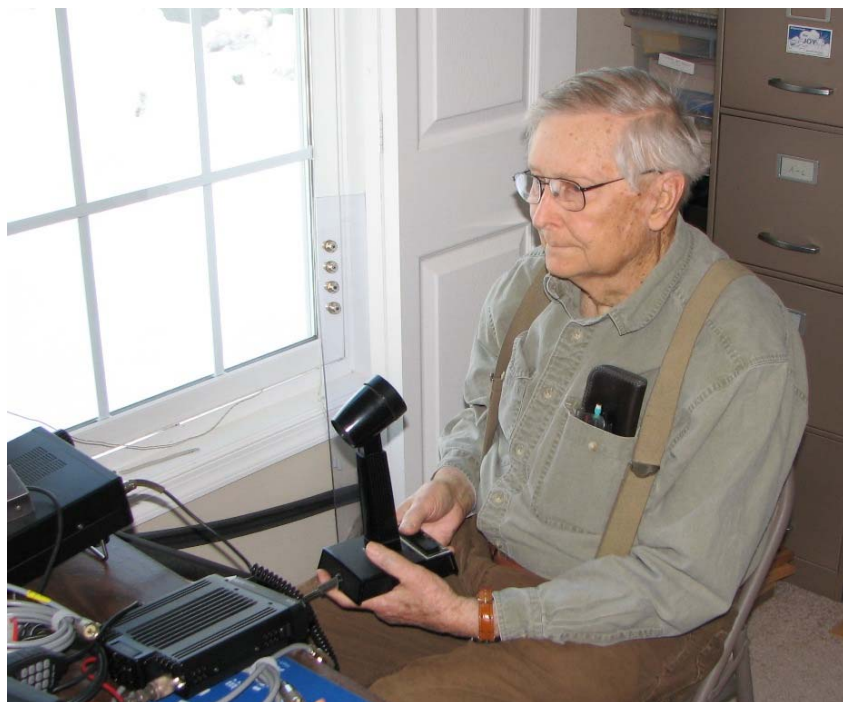
If you hear him on, ask him about the holes in the ground. But chances are, he can't tell you!

Rockingham County ARES Net Control Call Script

Calling all radio amateurs, calling all radio amateurs.

This is the ROCKINGHAM COUNTY AMATEUR RADIO EMERGENCY SERVICE NET, sponsored by the Massanutten Amateur Radio Association.

This net is a directed net which meets every Monday night at 8:00 p.m. for the purpose of training radio amateurs to handle emergency communications and to give them an opportunity to test their equipment.

Net control tonight is: *(your callsign)*

My name is *(your name)* and my location is *(your city or town)*.

This is a directed net, so please follow the instructions of Net Control.

At this time is there any EMERGENCY or TIME VALUED TRAFFIC for the net. If so, call now.

(Recognize the stations and handle any traffic immediately)

Do we have stations with ANNOUNCEMENTS for the net, if so your callsign ONLY please

(Recognize the stations but hold the announcements until after the roll call)

Do we have any liaisons to REGIONAL or SECTION NETS in the NTS, or any affiliated stations, such as MARS, CAP, other ARES or INDEPENDENT NETS. If so, your callsign ONLY.

(Recognize the stations and ask them to standby until after the roll call)

Are there any mobile, portable, short time, or stations operating on emergency power wishing to check in. If so, call now.

(recognize the stations, ask them individually if they can hold traffic and comments until after the roll call and announcements)

At this time we will take check-ins, by callsign suffix. If you have traffic, please state the nature of the traffic at the the time you check in.

(record your check-ins on your ARES Net log sheet)

Stations with suffix ALPHA through GOLF, call now.

Stations with suffix HOTEL through NOVEMBER, call now.

Stations with suffix OSCAR through TANGO, call now.

Stations with suffix UNIFORM through ZULU, call now.

Stations regardless of SUFFIX, call now.

At this time we will take stations with announcements or traffic only.

(Call the stations with announcements in order. At the end of each ask "Does any station need fills?" Recognize any stations asking for fills and direct them to contact the announcement station directly on the net.)

At this time we will secure the formal net and any mobile, portable, or short time stations needing to leave the net are now released.

Lets continue the informal portion of the net with a round of comments.

(Go to top of roll call list and ask for comments including any mobil, portable, or short time stations who have not left the net. Check periodically during the comments for late check-ins).

Is there any other traffic for the net or any other late check ins?

If not, this concludes the Rockingham County ARES NET.

Thanks to everyone for checking in. We would like to thank the trustees of the area repeaters for the use of their repeaters. At this time we will close the ROCKINGHAM COUNTY AMATEUR RADIO EMERGENCY SERVICE NET at _____ p.m. and return the frequency to normal amateur use.

PVARC Secretary's Report – December 4 Meeting

Mark Hensley N4YSA, PVARC President called the meeting to order at 1800 in the Day Room, Page Memorial Hospital in Luray. Twelve members were present. There were no visitors. Inasmuch as there were no announcements, Mark N4YSA called for a reading of the November Meeting Minutes and the Treasurers Report by the Secretary/Treasurer. Both were accepted as read.

Committee Reports were as follows: Dave K4DPF & Phil KQ4D for the VEC Subcommittee reported on the two individuals doing self-study, noting both expect to be ready to try for their licenses at the next scheduled VE exam session.

The Technical Assistance Subcommittee reported they had installed a new antenna for Geoffrey WD4LYO. Using a homebrew "Bazooka," (sometimes called a "spud-gun") made of cemented lengths of PVC pipe and charged with compressed air was triggered by a nifty solenoid switch that easily launched a tethered projectile over a 50 foot tree. The bazooka, built by Mark N4YSA was passed around for all to see and admire. Geoffrey reports the new G5RV antenna a great improvement to his station.

While no report was given by the Membership Committee - Phil KQ4D spoke on the desirability of getting area inactive hams back on the air to help increase PVARC membership. Geoffrey WD4LYO, the co-chairman responded that he was still working on combining several lists of area amateurs into his database and hoped to have a "working list" shortly. It was generally agreed that these "inactive" hams should be invited to attend PVARC meetings. Mark N4YSA commented that hams checking into the Sunday night Page County ARES net who are not members have been invited to "drop-by" and visit.

Reporting on Emergency Preparedness Committee activities, Dave K4DPF briefed the members on a recent exercise conducted at the Page Memorial Hospital Emergency Operations Center. He was assisted by Geoffrey WD4LYO. He noted that there were still some problems associated with WinLink2000 that needed to be resolved, but the station is operational. Dave also mentioned that three ICOM 706 transceivers were successfully installed in the Health South Rehabilitation Center Regional EOC.

Putting on his "Field Day" hat, Dave K4DPF discussed various issues to begin thinking about in planning for the 2010 event. He will reserve the same location (if possible) at Lake Arrow Head when the reservations become available in Jan/Feb. In the ensuing discussion, Morgan K4RHD volunteered to cook for the event and others made further suggestions to improve our score. Mark N4YSA asked that the members take time over the next month to think over things they

would like to see and provide ideas on a separate sheet of paper to be passed on to the ARRL Field Day Subcommittee for consideration. He would like to see a maximum effort made by PVARC next field day!

Several items of Old Business were taken up next. First: Status of the PVARC banner. Mark N4YSA reported that Geoffrey WD4LYO had provided the necessary artwork/graphic in a suitable format to the company and the banner is now a "work in progress." Hopefully we will have it shortly. Second: Carol KA4LAF, Dave K4DPF and Geoffrey WD4LYO discussed various aspects in the design of the proposed PVARC website. They had not met during the month, but have agreed to meet at KA4LAF's QTH to work on possible solutions; e.g., how to register and whether to buy a domain name; what the domain name should be: should the website be hosted at QRM.com or elsewhere; what should the site structure and content look like; and, what will it cost? Following a lively discussion, Mark N4YSA asked the working group to come up with recommendations, or better yet, make a short list for consideration by the membership to be voted upon at a future meeting. The Third and final bit of Old Business was to vote on the re-election of Bob Forrest KJ4HFU to a full two-year term as the second Member-at-Large on the PVARC Board of Directors. Since there were no other candidates, the motion to elect by unanimous consent was made, seconded and passed.

One last remaining item of business was presented by Bob KJ4HFU. He had been asked to look into the possibility of locating a local restaurant where PVARC could, if the members desired, have a short business meeting and a meal where friends and family could attend and socialize. Bob report that he had talked to Allen Chu, owner of Brown's Restaurant on Main St. in Luray. He said Mr. Chu would be happy to accommodate PVARC in either of two rooms separated from the main dining area depending upon the number attending. After a short discussion, a motion was made to adopt the proposal to meet on odd numbered months at Brown's Restaurant (at the usual 1800 hour); and, to continue meeting at Page Memorial Hospital, as we have been, on even numbered months. The motion was seconded and carried unanimously.

Mark N4YSA announced that, as provided in the Club by-laws, the January meeting could be moved if it would fall on/near a holiday (New Year's Eve). Therefore, the next meeting will be held on the second Friday, January 8, 2010 at Brown's Restaurant. He urged everyone to bring a family member, prospective ham or friend. Wishing everyone a Merry Christmas and a safe, happy and prosperous New Year, he adjourned the meeting at 1843.

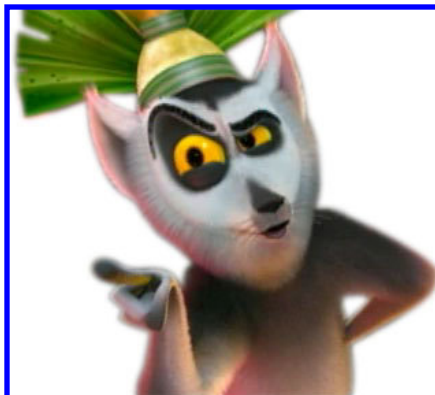
