Field Day with the Page Valley Amateur Radio Club

The club started their set up early Saturday morning, beginning with an 80-m loop in the trees for the HF rig, responsible for most of the contacts. The solar-powered station fed a 20-m colinear dipole, while the VHF station fed a 2m vertical, a 2m beam and a 6m beam supported by a 35-foot portable tower and rotator.

Although Lake Arrowhead is in the lee of the

2014 at Lake Arrowhead, the Town of Luray's beautiful recreation site about five miles east of town. The club operated using its club call sign of K4PMH in class 1A. Antennas for HF, 6m and 2m were strategically deployed. Power was supplied by a Honda emergency generator and a solar HF rig for additional points. About fifteen licensed hams participated, with the first three contacts made by 8-year old Brayden



valley from the 147.300 repeater and NVTN, a 75w signal helped to reach the hard-to-copy repeater at Bluemont, garnering us all the traffic passing points.

Overall, the club made 905 voice contacts and 529 CW contacts. The club earned additional points for passing traffic, visits by the county's emergency coordinator (served agency), a school board chairman (elected official), local news coverage, the ARRL digital message and more for a total of 5096 points. Several visiting hams took turns on the operator schedule, most notably **Brian/W3ATT** and **Ian/W0IMD**.



H.R. 4969: Amateur Radio Parity Act of 2014

Dear Congressman Goodlatte,

I am a constituent in your District and I want to bring an issue to your attention. I am a federally licensed Amateur Radio operator, one of 20,852 whom reside in Virginia. We provide communications support and participate in public service events on behalf of the community, during times of emergency by providing communications for local governmental agencies and non-governmental agencies (NGO) like the Red Cross and Salvation Army, communications support to the United States Military through their Military Auxiliary Radio System (MARS), to our neighbors when mainstream communications break down, and to the future of telecommunications as we participate in the development of cutting edge technology in this digital age. We take our work very seriously.

We cannot do any of these things, which we do at no charge ever to anyone we help, without being able to place an outdoor antenna on our property.

Recently a bi-partisan Bill, H.R. 4969, was introduced by Mr. Kinzinger (R-IL) and Mr. Courtney (D-CT) which would extend the ability to properly negotiate with developments that have restrictions that routinely preclude Amateur Radio operators from putting up even a simple wire antenna in a tree that would never be seen by the community. We already have this ability with local zoning ordinances, but we need to extend this ability to operators living under land use restrictions. All we are asking for is a reasonable accommodation.

As your constituent, I am asking that you support the bill by signing-on as a cosponsor. Please contact Rep. Kinzinger's office to do so.



PVARC Meeting Summary - July 11th, 2014

The Page Valley Amateur Radio Club held its monthly business meeting in the Page County EOC Training Room in Luray on this date. Bob Forrest/WO4MI, PVARC President, called the meeting to order at 1835. Fourteen members were in attendance.

Announcements: Patrick Sprague/KM4CVG was reintroduced, for the second time – but this time as the valleys' newest ham operator! He is to be congratulated, along with Harold Hall/KK4SYN (a.k.a. "Double H") who has upgraded to General Class.

Bob/WO4MI called for the Secretary & Treasurers Reports: The Secretary reported the summary minutes for last months meeting were printed in The Monitor. A motion was made to approve them as published. The motion was seconded and passed unanimously.

Carol/KA4LAF, PVARC Treasurer, reported the PVARC checking account (at the end of June) totaled: \$1,540.56; with \$32.00 in Petty Cash & \$18.48 in the Donut Fund. The total Cash on Hand is \$1,591.04. A check in the amount of \$200.00 will be given to Morgan/K4RHD this evening, as previously approved, to reimburse him for Field Day food expenses. The motion to approve the report was made, seconded and passed unanimously.

Bob/WO4MI asked if there were any committee reports.

<u>Technical Assistance Committee</u>: Mark/N4YSA & Gene/ KJ4HFO reported they had assisted Larry/K3JRR by replacing a transformer in his Hallicrafter radio and repairing a cord for his amplifier.

<u>Education Committee</u>: Morgan/K4RHD reported on his ongoing discussion with Bruce Snelling on the possibility of sponsoring or assisting in the formation of a Ham Radio Club at Page County High School. He will keep us informed.

<u>Widow's Assistance Committee</u>: Morgan/K4RHD reported no new activity in the past month. He is will be expects to be working on two "estate sales" shortly; one for Geoffrey/WD4LYO (SK) and possibly one for Jack Russell/W9NCJ (SK).

<u>PVARC Website</u>: Dave/K4DPF reports he has started work on a revised web site. The basic elements are done. Noted it is a work in progress and will demo after the meeting if desired and time permits.

<u>ARRL Field Day Committee</u>: "After Action Report" by cochairs: Tim/AK4CJ & Morgan/K4RHD. Overall, an outstanding success summarized in a PowerPoint presentation. 529

County Emergency Services (100 pts); and, Youth Participation (20 Bonus Points). Our final score of 5,096 points is up 1,352 points over last years score (3,744)!

In his final remarks **Tim/AK4CJ** thanked **Morgan/K4RHD** for being Field Day co-chair; everyone who brought equipment; and very special thanks to the set-up/tear-down crew. As a final observation he thought it would be helpful next year if the Page County ARES could arrange to call the net & pass traffic during Field Day. Other suggestions were: Provide cabling for automatic frequency change for the '746 transceiver; and, perhaps do a "dry run" a week before FD to ensure all cables, equipment, etcetera are ready. A suggestion to "consider a different site location to a more public location" was discussed, but not favorably received.

NEW BUSINESS: It was announced that a recent ARRL newsletter encouraged amateurs to comment on HR 4969 pertaining to proposed changes in the Restricted Covenants Antenna issue. Further info is available on the ARRL web site.

Zory/KB3VQC & John/KT4CB brought up FCC proposed limits on "drones." Recognizing that many amateurs are also users of radio control aircraft on 50 MHz and above, members might be interested in following up on pending proposals. While not actually a radio spectrum issue (at this time) it could affect future operations.

OLD BUSINESS: Bob/WO4MI announced that the Nominating Committee would be comprised of the four sitting officers since all have expressed an interest in stepping down. Again, if anyone is interested in stepping forward to fill the positions of President, Vice-President, Secretary or Treasurer please let us know. Help PVARC grow, consider running for one of the leadership positions.

There being no further business to come before the members, **Bob/WO4MI** called for a motion to adjourn @ 1935 which was made/seconded and passed.

on November 1st from Noumea, New Caledonia, and head towards the DXCC entity Ches-

terfield Islands (OC-176) first. Their voyage will take some 100 hours (about 4 days) and ex-

pect to arrive at Chesterfield on November 5th. Look for Mic to use the callsign TX5C which is a reissued callsign that was used during the last Clipperton DXpedition (March 2008) -- this will probably confuse some logging programs. They will depart from Chesterfield on November 10th, and sail next toward the New Caledonian's D'entrecasteaux Reefs (OC-058). This trip will take 80 hours to reach the reef on November 14th, and Mic will be active as TX5E until he departs on November 18th for Belep Islands (OC-079). This will be his last island, and Mic will operate as TX5B starting about November 21st for three days before heading back to Noumea on **November 24th**. The return trip is expected to take 4 days (November 28th). Between each leg of the trip, Mic will use the callsign FK8IK/MM. Operations from each island will be on 40-10 meters using 100 watts into a vertical antenna (homemade) and an antenna tuner. Modes will be CW and SSB. ADDED NOTES AND RE-

MINDERS. Mic will be the sole operator, so please have a little patience. Also, the TX5C operation will only count for the Chesterfield Islands (FK/C), and the TX5B & TX5E will only count for New Caledonia for DXCC purposes.


